FURTHER AGREEMENTS: *Full payment is due upon signing this agreement, unless otherwise discussed and agreed. This contract is entered into in the State of North Carolina. When above services are selected, consultant will provide client(s) with information and related assistance in school or program selection. Client will provide consultant with all background history and relevant information, including Parent Narrative, and will give permission for other professionals to release information to consultant. It is expressly understood that consultant makes no representation or guarantees as to the student's chances of being admitted to any school or program, nor of succeeding when admitted. Consultant neither solicits nor accepts compensation from any school for placement of a client.*

During the first three months of placement at a selected school or program, if the school, parent(s), and student feel that relocation is necessary, consultant will assist in relocating the student to an alternative placement at no additional consulting charge. However, if, at any time, the student is dismissed or required to withdraw from a selected school or program, and consultant's services are engaged for another type of placement, client will pay an additional fee to consultant. If client withdraws student from program or school against medical advice, client will pay consultant an additional fee for research and guidance for another placement if client so requests.
